A. Qualification:-

- (i). MBBS with Post Graduate Degree/ DNB/ Diploma or equivalent as per residency scheme in concerned specialty from a recognized University/ Institution.
- B. Age: Below 45 years, On Date of Interview, as per order No.F.DHF&W/Q015/57/2016-HR-Medical-secy(H&FW)/CDNo.112425062/1502-08 dated 26.11.2020. Age limit is relaxable by 05 year for SC/ST candidates.
- C. <u>Pay:</u>- Basic of RS. 67700/- in pay Matrix 11 of 7th CPC with other allowances as admissible per month.
- D. Must be registered with Delhi Medical Council.
