2. ELIGIBILITY CRITERIA FOR THE POST OF SENIOR RESIDENTS -

A. Qualification:-

- (i). MBBS with Post Graduate Degree/ DNB/ Diploma as per residency scheme in the specialty of **Anesthesia/Medicine/Surgery** from a recognized University/ Institution.
- (ii) If above are not available, Degree/Diploma in Family Medicine / Respiratory Medicine may be considered
- (iii) If above are not available, candidates who have completed three years of residency for degree/diploma in concerned specialty and awaiting results may be considered.
- (iv) If above are not available, MBBS with 03 years experience (preferably from Govt. hospital) out of which at least 02 years experience should be in mentioned specialty i.e. Anesthesia/Medicine/Surgery/Family Medicine/Respiratory Medicine may be considered.
- B. Age: Below 45 years, On Date of Interview, as per order No.F.DHF&W/Q015/57/2016-HR-Medical-secy(H&FW)/CDNo.112425062/1502-08 dated 26.11.2020.
- C. Pay:- Basic of Rs. 67,700/- in pay Matrix 11 of 7th CPC with other allowances as admissible as per Rule.
- D. Must be registered with Delhi Medical Council.

- E. Appointment will be initially for a period of 89 days or till specialist joins, whichever is earlier and may be extended beyond 89 days maximum upto 03 years on the same conditions based on work and conduct report or till specialist joins, whichever is earlier.
- F. Appointment will be subject to medical fitness and verification of certificate of educational qualification/age/caste/DMC registration and internship completion certificate etc.
- G. Candidate must not have completed three years Senior Residency from any Govt. Hospital(*)
- (*) Further in case of non-availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of relaxation of provision as per circular No. F.No. 121/26/2010/H&FW/1996-2045, dated 10.06.2011 issued by Health & Family Welfare Department, Govt. of NCT of Delhi with the following relaxation.
- 1. In the Specialties where no fresh candidates are available, candidates, who have completed 3 years of Sr. Residency, may also be allowed to appear in the interview.
- 2. Separate merit list would be prepared for the candidates who have completed their residency of 3 years as SR.
- 3. Firstly, the list containing name of fresh candidates would be exhausted for appointment as SR and the second would be used only after that.
- 4. Further, all Senior Resident appointment from second list will be for one year only (based on the mentioned T&C) for those who have already completed 3 years of Residency. It would not be renewable after one year.

H. CONDITION FOR RECRUITMENT -

- A. All the eligible candidates should report in the office of the undersigned at 9.00 A.M. [Time for enrollment from 9.00 A.M. to 10.30 A.M. only] on the day of interview.
- B. For candidates applying for OBC category, the certificate must be issued by the competent authority of Govt. of NCT of Delhi along with the current F.Y. Non creamy layer certificate. The certificate should be issued for Delhi specifically. Persons with disabilities shall be given relaxation as per rule.

- E. Candidate must submit their Bio-Data with attested photo copy of certificates and original documents should be shown at the time of interview.
