2. ELIGIBILITY CRITERIA FOR THE POST OF SENIOR RESIDENTS -

A. Qualification:-

- (i). MBBS with Post Graduate Degree/ DNB/ Diploma or equivalent as per residency scheme in concerned specialty from a recognized University/ Institution.
- B. Age: Below 45 years, On Date of Interview, as per order No.F.DHF&W/Q015/57/2016-HR-Medical-secy(H&FW)/CDNo.112425062/1502-08 dated 26.11.2020. Age limit is relaxable by 05 year for SC/ST candidates.
- C. Pay:- Basic of RS. 67700/- in pay Matrix 11 of 7th CPC with other allowances as admissible per month.
- **D.** The candidate must have completed internship.
- E. Must be registered with Delhi Medical Council.
- **F.** Appointment will be initially for a period of 89 days or till the recruitment of Senior Resident is done by Centralized Committee for recruitment of SRs/JRs, whichever is earlier and may be extended beyond 89 days maximum upto 03 years on the same conditions based on work and conduct report.
- **G.** Appointment will be subject to medical fitness and verification of certificate of educational qualification/age/caste/DMC registration and internship completion certificate etc.
- H. Candidate must not have completed three year senior residency from any Govt. Hospital (*)

^{*} In case of non-availability of category candidates, seat shall be open for all.

- (*) Further in case of non-availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of relaxation of provision as per circular No. F.No. 121/26/2010/H&FW/1996-2045, dated 10.06.2011 issued by Health & Family Welfare Department, Govt. of NCT of Delhi with the following relaxation.
- 1. In the Specialties where no fresh candidates are available, candidates, who have completed 3 years of Sr. Residency, may also be allowed to appear in the interview.
 - 2. Separate merit list would be prepared for the candidates who have completed their residency of 3 years as SR.
- 3. Firstly the list containing name of fresh candidates would be exhausted for appointment as SR and the second would be used only after that.
- 4. Further, all senior Resident appointment from second list will be for one year only (based on the mentioned T&C) for those who have already completed 3 years of Residency. It would not be renewable after one year. Senior Resident may be assigned duties in Emergency Department as & when required in case of any exigency.
